FACTS OF THE CASE:

THE COMPLAINANT, WITNESS AND POLICE WERE INTERVIEWED AT NORTHEAST DETECTIVES AND STATED THE FOLLOWING IN SUMMARY.

ON 01/08/13 AROUND 10:11PM THE COMPLAINANT AND WITNESS WERE WALKING IN THE AREA OF 10960 BUSTLETON AVE WHEN THEY NOTICED THE DEFENDANT ATTEMPTING TO GET THEIR ATTENTION. THE COMPLAINANT AND WITNESS SUSPECTED TROUBLE FROM THE DEFENDANT AND CONTINUED WALKING AWAY. AT THAT POINT THE DEFENDANT BEGAN TO RUN TOWARDS THEM, CHASING THE COMPLAINANT. THE COMPLAINANT RAN FOR A SHORT DISTANCE BEFORE SLIPPING AND FALLING TO THE GROUND. WHEN THE DEFENDANT GOT TO THE COMPLAINANT, HE BEGAN TO ASSAULT HIM BY PUNCHING AND KICKING HIM SEVERAL TIMES IN THE FACE AND BODY AREA. THE DEFENDANT THEN STOPPED ASSAULTING THE COMPLAINANT AND INSTRUCTED HIM TO GET ON HIS KNEES. ONCE ON HIS KNEES HE TOLD THE COMPLAINANT TO GIVE UP WHAT HE HAD AND THEN THEN KICKED THE COMPLAINANT AGAIN IN HIS FACE KNOCKING HIM BACK DOWN TO THE GROUND. THE DEFENDANT GOT ON TOP OF THE COMPLAINANT AND STATED TO HIM THAT HE WAS GOING TO STAB HIM. HE PRODUCED A FOLDING POCKET KNIFE FROM HIS POCKET AND ATTEMPTED TO STAB THE COMPLAINANT TWICE IN HIS TORSO AREA

POLICE ARRIVED ON LOCATION AND OBSERVED THE DEFENDANT AND TWO OTHER PERSONS ON SCENE. POLICE ORDERED THE DEFENDANT AND OTHER PERSONS TO PLACE THEIR HANDS ON A NEAR-BY VEHICLE FOR OFFICER SAFETY. AT THAT POINT THE DEFENDANT ATTEMPTED TO WALK AWAY FROM POLICE. OFFICERS STOPPED AND DETAINED THE DEFENDANT AND CONDUCTED A SAFETY FRISK FOR WEAPONS. RECOVERED FROM THE DEFENDANT WAS A BLACK HANDLED FOLDING KNIFE FROM HIS POCKET. THE DEFENDANT AND KNIFE WERE SUBSEQUENTLY IDENTIFIED BY THE COMPLAINANT. THE KNIFE WAS PLACED ON PR# 3034778.

THE COMPLAINANT AND WITNESS BOTH STATED THAT THE DEFENDANT THREATENED TO KILL THE COMPLAINANT DURING THE ASSAULT. THEY ALSO STATED THAT AFTER THE DEFENDANT WAS ARRESTED BY POLICE THAT HE THREATENED THEM IF THEY COOPERATED WITH POLICE AND WOULD SHOW UP AT THEIR HOMES WHEN HE GOT OUT.

THE COMPLAINANT SUFFERED CUTS AND CONTUSIONS TO HIS FACE AND HEAD AREA DURING THIS INCIDENT. NOTHING WAS REPORTED TAKEN FROM HIM.

DURING THE DEFENDANTS INITIAL PROCESSING HE PROVIDED POLICE WITH A NAME OF (SAROVA DOLIGINAV 12/03/92). WHILE BEING TAKEN INTO CCTV HE THEN PROVIDED POLICE WITH A VARIATION OF THE FIRST NAME PROVIDED (SARVOA BOLYEGENAV 12/3/92). HE THEN PROVIDED THE ASSIGNED WITH A THIRD VARIATION OF HIS NAME (SARDOR BOLYAGANOV 12/02/92) AND STATED HE WAS 21 YEARS OLD. THE PROVIDED NAMES WERE RUN THROUGH POLICE NCIC/PCIC/BMV SYSTEMS AND RETURNED ON RECORDS. THE DEFENDANT THEN PROVIDED (SARDOR BOLYAGANOV 10/27/91) WHICH WAS VERIFIED IN POLICE SYSTEMS.
